#### Periodically billing

Upon execution of your transaction your account is credited/debited with the full amount, which facilitates your internal bank bookkeeping. In this case, RBI's payment transaction charges will be settled only once a month or quarterly.

#### **Multidimensional Display of Data**

You have the possibility to select your bill by account and period. Additionally you can retrieve and analyse detailed information on transactions and download them to csy or xls.

#### camt.086, pdf -Processing of Data

Of course you can save all data and further process it electronically. Data can easily be exported in a comfortable manner. The most common formats are already included in the application. By one click your data can be transferred into camt.086 and pdf-format.

### **Availability of historical Data**

The bills and therefore all information regarding your transactions are retrievable online up to 24 months.
